Release and Waiver of Liability Agreement

COVE Programs involve a variety of activities in both indoor and outdoor settings. Activities include warm-ups, games, group sport events and sometimes rigorous physical activities. The level of participation is up to the individual's choice. Yet there is a risk which must be assumed by each participant, that due to the demands of certain activities, he or she may incur injury. As such there are certain risks inherent in such activities.

I hereby acknowledge that I am aware of these risks. I agree for myself and children to follow all safety instructions and ask questions if I do not understand. I also acknowledge that, despite careful precautions, there are certain inherent risks of injury in these programs and activities, and I accept those risks. I understand that each participant must assume the risk of injury or disability that could result from any of the activities.

In consideration of your accepting me and/or my child(ren) for participation in the above-named program, activity, or sport, I hereby, for myself, my heirs, executors, assigns and administrators, fully waive and release any and all rights, causes of action, claims and damages that I or my child or children may have against COVE Homeschooling Association, Covenant Community Church, by whatever legal name, DBA, title or organizational form, and their volunteers, invitees, teachers, members, visitors, participants, students, administrators, agents, employees, representatives, successors and assigns for any and all harm, stress or injuries suffered by my child or children that arise out of any program, activity or sport undertaken, authorized, permitted or sponsored by the above-named Associations, entities and organization(s).

I further acknowledge and agree that I have the legal right to authorize and execute the foregoing waiver and release and do hereby agree to hold the above-named Association, entities and organization(s) and said persons associate or involved therewith harmless of and from any and all liability other than liability arising out of intentional misconduct, of whatever nature, which may arise out of or result from such participation, activity, observation or involvement.

For the consideration stated above, I further agree that in the event that my child or I should make any claim against the above-named organization(s) or persons for relief or damages arising out of the above-named program, activity, or sport, I will personally indemnify, defend, and hold harmless the organization and its agents, employees, representatives, successors, and assigns and all others above named against any and all loss and damage occasioned thereby, including attorney's fees.

I have read and understand this Agreement, waiver, release and hold harmless and I have willingly placed my signature below as evidence of my acceptance of all the conditions and promises contained herein. (If participant is a minor, I also agree that if my child breaks his/her promises, he/she may be sent home at my expense).
